SI. The school is directed to ensure that :

No.

- The total number of sections of Bal Vatika shall be restricted to 6 (2 sections each in Bal Vatika I, II & III respectively). The total number of sections of the school from class I to XII shall be restricted to 30 of which not more than 1/3rd sections may be used for senior secondary classes. The optimum number of the students shall be restricted to 40 in each section. Further, increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law and availability of class rooms of greater than 500 sq ft dimension.
- The mathematics lab is under stocked and temporarily arranged with insufficient storage and there is no sitting facilities. Hence the school is directed to upgrade the lab as per SoP issued by the Board and submit the videographic compliance within 3 months on SARAS portal.
- 3 School has not maintained and upgraded Composite lab as per SoP. It does not have separate workstations for Biology section arrangements. Safety feature like exhaust fan, fire extinguisher and emergency exit are also not seen in Composite lab. Hence the school is directed to upgrade the labs as per SoP issued by the Board and submit the videographic compliance within 3 months on SARAS portal.
- Inappropriate sitting arrangements are there in all three science labs (Physics, Chemistry and Biology) and safety feature like exhaust fan, fire extinguisher and emergency exit are also not seen in Chemistry lab. Hence the school is directed to upgrade the labs as per SoP issued by the Board and submit the videographic compliance within 3 months on SARAS portal.
- The library is seen understocked and no reading space for staff. Hence the school is directed to upgrade the library as per SoP issued by the Board and submit the videographic compliance within 3 months on SARAS portal.

The computer lab does not have appropriate furniture, plastic chairs are there for sitting. Hence the school is directed to upgrade the lab as per SoP issued by the Board and submit the videographic compliance within 3 months on SARAS portal.

- 7 The water and sanitation certificate does not have validity period. Hence the school is directed to obtain fresh water and sanitation certificate with all the details correctly and upload the same on SARAS portal within 3 months.
- 8 The school shall conduct training of its teachers with CoE Bhubaneswar within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

- The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
- The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- The school shall renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.

 Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.

8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.

 The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.
